Abstract: This guide identifies and suggests allocation of responsibilities to various parties involved in concrete rehabilitation in the United States; however, the guidance presented may apply to contractual relationships addressing concrete construction in other parts of the world. In some cases, the responsibilities outlined carry the force of law. In others, there are options that could be incorporated into a particular contract.

Abstract: This guide contains materials, design, and construction recommendations for concrete slabs-on-ground and suspended slabs that are to receive moisture-sensitive flooring materials. These flooring materials include sheet rubber, epoxy coatings, vinyl composition tile, sheet vinyl, carpet, athletic flooring, laminates, and hardwood.
